SortMyCash Fees

SortMyCash will not charge you any fee directly (subject to cancellation charges as described in our Terms of Engagement enclosed). However, you will be recommended to our data breach claim partner solicitors, Chan Neill Solicitors who will look to pursue the claim on your behalf. The terms of Chan Neill Solicitors agreement will be stipulated by them in the contract, but for reference it will be on a No Win, No Fee basis and you will be charged 30% + VAT of any Compensation (as defined in the Terms of Engagement), plus the costs awarded by the court, which may be recoverable from the opposition or covered by an After The Event ('ATE') or Before The Event ('BTE') insurance policy. SortMyCash will be paid a referral fee from the firm of solicitors for providing our services to you and the firm of solicitors. Our fee will be paid out of the 25% + VAT that Chan Neill Solicitors will charge you for a successful claim. This is set out in our Terms of Engagement. Being recommended by SortMyCash will not affect the amount that you pay and you would pay the same had you chose to proceed with them directly.

Recommendation

You are free to choose your own appointed legal expert or dismiss our recommendation to appoint a legal representative, but it is our position to recommend using our data breach claim solicitor partner, Chan Neill Solicitors, to take the stress away from claiming and in order to maximise the compensation awarded for the inconvenience, distress and breach of trust that you have suffered due to the breach of your personal and / or financial details.

Authorisation to SortMyCash

I understand and acknowledge that I can seek to recover the compensatory monies from Arnold Clark or their insurer myself free of charge. However, I have instead chosen to proceed via SortMyCash and Chan Neill Solicitors. I hereby authorise SortMyCash to provide my claim and personal details to Chan Neill Solicitors in order for them to contact me and to facilitate an agreement to pursue compensation on my behalf for the data breach.
